A REMINDER FROM YOUR CITY COUNCIL:



It has been brought to the attention of the City Council that there are parking problems on City Streets. Below are a few reminders when parking your vehicles....

***It is *against the law* to park within 50 feet of a Stop Sign or Yield Sign, which will obstruct the view of any traffic control device located on the side of the roadway.**

***Parking on City Streets is not permitted. Please move all vehicles currently parked on the pavement!**

***It is against City Ordinance #400 for any unlicensed and/or uninsured vehicles, or storage of any inoperable vehicles to be on the City Right-of-Way. As a reminder, the City Right-of-Way is 30 feet in each direction, measured from the center of the City Street.**

***No RV (Recreational Vehicle) may be used as residential occupancy on private property within City Limits for longer than a one-month period. This violates City Ordinance #120.**

If any of the forementioned violations are not corrected, the City of Grass Valley has the right to issue a citation, assess a Civil Penalty, or abate the violation at your expense.

Note: The Speed Limit on ALL City Streets is **20 MPH**. We want to keep our City and Residents as safe as possible, PLEASE DO NOT SPEED on our Streets!!!

RECYCLING & BURN PILE INFORMATION

Due to an overwhelming amount of "garbage" being disposed of at the Recycling Center, we are including a handout of what is allowed versus what is not allowed in the Recycle Bins. If you have any further questions, you may contact City Hall or The Dalles Disposal.

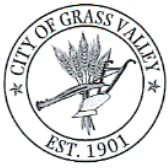

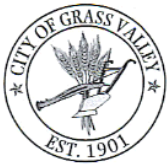
